AN ACT

To amend an Act to create and establish the St. Marys Airport Authority, approved March 4, 1964 (Ga. Laws 1964, p. 2438), so as to provide that the members of said airport authority shall serve at the pleasure of the Mayor and City Council of the City of St. Marys and may be removed from office with cause; to provide an effective date; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

Section 1. An Act to create and establish the St. Marys Airport Authority, approved March 4, 1964 (Ga. Laws 1964, p. 2438), is hereby amended by adding to the first sentence of Section 3 immediately following the phrase "shall be appointed by", the following:

" , shall serve at the pleasure of, and may be removed with cause by, ",
so that said first sentence of Section 3, when so amended, shall read as follows:

"The Saint Marys Airport Authority shall be composed of five members who shall be appointed by, shall serve at the pleasure of, and may be removed with cause by, the Mayor and City Council of the City of St. Marys, Georgia."

Section 2. This Act shall become effective upon its approval by the Governor or upon its becoming law without his approval.

Section 3. All laws and parts of laws in conflict
with this Act are hereby repealed.
